MRAC eligibility criteria:

To be eligible for MRAC housing, you must:

- Be Aboriginal, Torres Strait Islander or have an Aboriginal partner and/or custody of Aboriginal children; or be able to Provide 'Proof of Aboriginality' when requested.
- Be resident in the region you wish to apply for or have links to that area;
- Can provide two rental references, or if unable to, demonstrate you will be able to manage a residential tenancies agreement, look after the property and pay rent; and
- Can provide income documentation and photo identification for all household members 18 years of age and over; and
- Sign relevant release of information forms to allow MRAC to check your eligibility.

Your application cannot be approved until you have provided all the requested documentation. If you receive a Centrelink benefit and/or pension as your main source of income, MRAC will require you sign up for Centrepay rent deductions when you are housed with us.

If you are relying on a Department of Communities (Housing/Homes West) reference, you must complete the Information Release Authority attached.

If you require assistance completing this application or in providing the requested documentation, please call our office on telephone number 9923 0055 for support.

All sections of this application must be completed and signed by all applicants.

All required documentation must be supplied within six weeks of date of lodgment or the application will lapse and the application process started again.

Applying for MRAC housing – what you need to know

Welcome to MRAC. We are an Aboriginal community housing provider covering the Mid-West and Gascoyne Regions in WA.

To make sure we meet your long term housing needs, please complete the attached application form and provide all the information asked for.

If you have had a tenancy with Department of Communities (formerly Homes West), you must also complete and sign the Information Release Authority attached to the application.

All parts of the form must be completed so MRAC can fairly assess your eligibility. This includes:

- Proof of all household income so we can make sure your housing is affordable for you;
- Details of any former rental references;
- Photo identification & income documents for everyone 18 years of age and over; and
- Names & birth dates for everyone to be housed with you.

If you have had a previous bad rental housing experience, it doesn't necessarily mean you are ineligible for MRAC housing.

What happens to my application when I lodge it with MRAC?

Once your application is lodged, MRAC will:

- Check all paperwork is provided:
- Make sure your income is sufficient to meet your housing costs;
- Undertake any rental references;
- Check your eligibility for the location and bedroom size on your application; and

• Ensure your eligibility as an Aboriginal person or family.

Who decides if I am eligible for MRAC housing?

A Manager reviews all information provided including your income, any rental references, and where you want to live including the size of the property you have applied for.

Using the MRAC Eligibility Policy, the Manager will decide whether or not you are eligible for MRAC housing. In some circumstances, you may be invited to an interview with MRAC.

How will I know if my application is approved?

A letter is sent to all approved applicants advising them their housing application is approved and which waiting list/s it is approved to.

It is rare that an application is not approved but if you have any concerns, please talk to us. MRAC wants to support you into stable housing.

If your application is not approved, you have the right to lodge an appeal against the decision.

An independent Appeals Committee will review all the information you provided and MRAC's decision and make their own decision on whether you should be eligible or not.

When will I be offered housed?

This depends on the location and the size of the property you have applied for.

All housing applicants must wait their turn for housing. If you wish to apply for priority housing, there are very strict guidelines and criteria you must meet to be eligible.

If you think you are eligible for priority housing, please discuss this with a MRAC staff member.

It is important that you keep your contact details up to date so we can quickly find you if a property becomes available.
